Senior Citizen Savings Scheme

- An individual who has attained the age of 60 years or above on the date of opening of an account or an individual who has attained the age of 55 years or more but less than 60 years and has retired under Superannuation, VRS or Special VRS, can open an account.

- Retired personnel of Defence Services (excluding Civilian Defence employees) may open an account on attaining the age of fifty years subject to the fulfilment of other specified conditions.
- A depositor may open an account individually or jointly with spouse.
- The account can be closed after expiry of 5 years from the date of opening of account.
- The depositor may extend the account for further period of 3 years.
- The account shall be opened with a minimum deposit of one thousand rupees or any sum in multiple of one thousand rupees not exceeding Rupees Fifteen lakhs.
- The deposit made under these rules shall bear interest as directed by Govt of India from time to time quarterly.
- At present it is 7.40% per annum.
- If the interest payable every quarter is not claimed by an account holder, such interest shall not earn additional interest.
- Both the spouses can open single account and joint accounts with each other.
- The depositor may nominate a person or more than one person.
- The deposit made at the time of opening of the account shall be paid on or after the expiry of five years or after the expiry of eight years where the account was extended from the date of the opening of the account.
- Deposits in SCSS qualify for deduction u/s 80-C of Income Tax Act.

Jackson takes oath as first Black woman SC Justice

Top court retains conservative majority

The U.S. made history on Thursday as Ketanji Brown Jackson was sworn in as the first Black woman to serve in the Supreme Court.

The 51-year-old's appointment by Democratic President Joe Biden means white men are not in the majority on the nation's highest court for the first time in 233 years.

While Justice Jackson's confirmation is a milestone, it would not change the 6-3 conservative majority in the court, which has come under fire for recent rulings broadening the right to bear arms and viscerating abortion rights.

Justice Jackson spoke only to say her oaths during Thursday's brief ceremony.

The appointment presents an opportunity for Biden administration to pivot from a spate of bad news in recent months, with Mr. Biden's poll ratings still languishing below 40% amid runaway inflation ahead of midterm elections in November.

Four of the Justices on the nine-member court are now women, making it the most diverse bench in history.

External debt rose \$47.1 bn to \$620.7 bn in FY22: RBI data

External debt to GDP ratio declined to 19.9% from 21.2%

India's external debt rose to \$620.7 billion at end-March 2022, recording an increase of \$47.1 billion over the year earlier period, Reserve Bank of India (RBI) data showed.

The external debt to GDP ratio declined to 19.9% at end-March 2022, from 21.2% a year earlier.

Valuation gains on account of the appreciation of the U.S. dollar vis-à-vis the Indian rupee and major currencies including the Japanese yen and euro was estimated at \$11.7 billion.

"Excluding the valuation effect, external debt would have increased by \$58.8 billion instead of \$47.1 billion at



end-March 2022 over end-March 2021," the RBI said.

India's long-term debt (with original maturity of above one year) rose to \$499.1 billion, recording an increase of \$26.5 billion over its level at end-March 2021, RBI data showed.

During the same period, the share of short-term debt

in total external debt increased to 19.6% from 17.6%.

Similarly, the ratio of short-term debt to foreign exchange reserves increased to 20%. U.S. dollar-denominated debt remained the largest component of external debt, with a share of 53.2%.

Separately, the RBI said net claims of non-residents on India increased by \$5.6 billion during the fourth quarter of 2021-22 to \$359.8 billion in March 2022.

"This rise in net claims was due to larger decline in the Indian residents' overseas financial assets... when compared to the decline in foreign-owned assets in India," the central bank said.
